- Less Single Occupancy Vehicle trips-archived by transit services, expansion of transit and multimodal

- E-bike rental services to get more people who bike (to capture interested but concerned)
- Ability to get additional funding to provide MPO flexibility and more local maintenance of facility
- Fully connected and safe system for all modes of transportation
- City-wide traffic greenway (prioritize over other things)
- Budget that reflects priorities (city/county)
- Support quality and healthy living for everyone
- Every other street connected to trails and Dedicate every other street to non-motorized modes
- Every person to live within a ¼ mile of high frequency transit
- Equitable transportation
- More planning for equity upfront
- Comp plan to make easier for outside traffic to get through town
